

Registry Credential Commissions Grant

The Wisconsin Registry received a grant that covered the complete cost for Registry Credential students to commission who were not already supported by a T.E.A.C.H. scholarship or other grant funding. Funding for this grant has come to an end and was provided by the Department of Children and Families through the Preschool Development Grant (PDG). We are happy to announce that 79 individuals used the grant to pay for their commission in April, May, and June this year!

FREE FOUNDATIONAL CHILDCARE TRAINING

Beginning June 1, 2022, the Department of Children and Families (DCF) is funding free Foundational Child Care Training. This exciting program will provide accessible and affordable training and support to new child care professionals to improve the workforce shortage in child care.

The Child Care Foundational Training courses cover the following non-credit trainings delivered in an interactive online, interactive correspondence, and in-person format:

- Introduction to the Child Care Profession
- Fundamentals of Infant and Toddler Care
- Fundamentals of Family Child Care
- Skills and Strategies for the Child Care Teacher

Membership Application Processing

Member Steps



Create Registry Account

Create a free Wisconsin Registry account. This is the first step to become a Wisconsin Registry member.



Apply for Membership

Log in to your Wisconsin Registry account. Click the Apply/Renew button. Complete application, including education, and employment history, and submit.



Submit Payment Send Documentation

Pay membership fee or apply coupon code. Mail or email documentation. Request official transcripts. If you have no documentation, click "I have no documentation to submit."

Wisconsin Registry Steps

Verification

Wisconsin Registry staff enters documentation and official transcripts; Determine Registry Career Level and preliminary licensing positions.



Complete File Review

Wisconsin Registry staff prepares new documents and review all official transcripts for verification.



Document Intake

Wisconsin Registry staff checks in physical and digital mail in the order which they are received.



Once applied, you will receive an email from support@wregistry.org



Log in to your Wisconsin Registry account for application updates

Allow 5-7 weeks for our team to process your complete application



After processing, email sent to members to access a digital Wisconsin Registry Certificate
