GENERAL MEMBERSHIP NOW FREE!

The Wisconsin Registry has been grateful to receive funding the last four years from the Department of Children and Families (DCF) and the Preschool Development Grant (PDG) to offer the PDG coupon. The coupon code covered the cost of our general membership application fee. The current coupon code PDG2023 has come to an end as of today, November 1, 2023.

However, we are excited to announce that general Registry Membership is now **FREE!** Anyone applying for general membership will no longer see a fee with the application. New individuals can join the Wisconsin Registry, as well as those renewing their membership can do so for **FREE!** ***For those renewing with a current membership, there's no rush to renew now. We recommend waiting closer to your expiration date to apply.***

Individuals applying to be a Wisconsin Registry Trainer or Technical Assistance Professional for the first time will still have to pay a \$15 endorsement fee. The annual fee to become a Wisconsin Registry approved Training Sponsor Organization (TSO) remains the same at \$25.00.

We are excited about this change and hope it can be one less worry for child care providers. Please contact us with any questions.

Foreign Transcript Evaluation

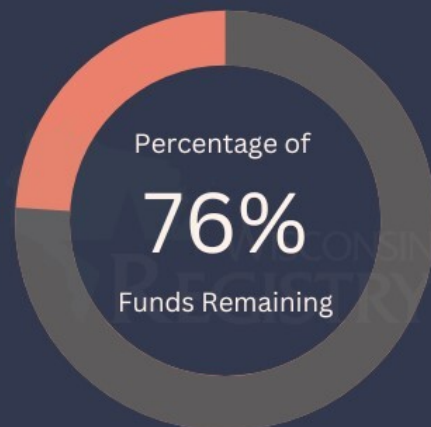
