One of the many benefits of applying for Wisconsin Registry membership is the reports that become available to individuals. The first five reports below are available to current Wisconsin Registry members, while the last two are available at anytime to Wisconsin Registry account holders.

Reports Available when Membership is Current:

 Registry Certificate of Achievement: This certificate includes the assigned Registry Career Level, preliminary position qualifications, licensing requirements, and recent training hours. This certificate is only available when Registry membership is current.

- Training List: This report includes a list of all training verified on the Registry account. It includes details like training title, date completed, hours, training level, and the Training Sponsor Organization. This report is only available while Registry membership is current.
- Learning Record: This report reflects the Registry Certificate of Achievement. It includes recent training information, employment history, verified education, and preliminary position qualifications. This report is available while Registry membership is current.
- Content Area Summary: This report is a sum of all training verified on the Registry account by content area. This report is available while Registry membership is current.
- Detailed Training List: This report is an expansion of the Training List report. It includes all details associated with the verified training on the personal Registry account. This report is available while Registry membership is current.

Reports Available Any Time:

- Child Care Foundational Training Certificate(s): This report includes the
 digital certificate for any child care foundational training completed, such as
 Introduction to the Child Care Professional and Skills & Strategies for the
 Child Care Teacher. This report is available anytime and has replaced
 the physical postcard certificates that were mailed to individuals.
- Registry eID: This report contains information regarding your Registry account, like name and Registry ID number. It also includes a QR code, which can be scanned at Registry approved training to mark attendance. This report can be accessed at any time.

UTILIZING INDIVIDUAL REPORTS

Utilizing individual reports within your Wisconsin Registry account can determine the next steps for professional development. One report to highlight in aiding with professional development is the **Content Area Summary report**. This report, which also can be labeled as Core Knowledge Summary, totals all training hours by content area, which houses the core competencies. **Core competencies** are expectations for what the workforce should know (content) and be able to do (skills) in a respectful & competent matter (attitudes) in their roles working with and/or on behalf of children and their families. The core competencies are organized within 12 content areas. Based on the Content Area Summary report, an individual may determine they need more training in one content area over another.



The example above shows content areas 1-12. However, you will notice some of the content areas are missing. This indicates content areas you may wish to find training in. The report also breaks down training by level (Registered, Tier 1, Tier 2, Tier 3, Tier 4).

If you are a **Registry Level Three** in the example above, you may decide to take tier training in content area number 2, Family Systems and Dynamics. This would allow you to work towards a Registry Level Four and complete training in a content area you have not done yet. To locate available trainings, utilize the **Statewide Training Calendar.**


