


### **OFFICE CLOSED: JULY 4TH**

#### BY THE NUMBERS



The Wisconsin Registry continues to see record numbers when it comes to membership applications. The graphic above shows the steady increase in submitted membership applications over the past five years. We set another record this year, averaging 2,443 membership applications per month from January through May for a total of 12,218 applications!

Our staff has also been working hard to finalize those record-setting number of applications coming in. In May, our staff finalized 3,303 membership applications which is the most of any month ever!
