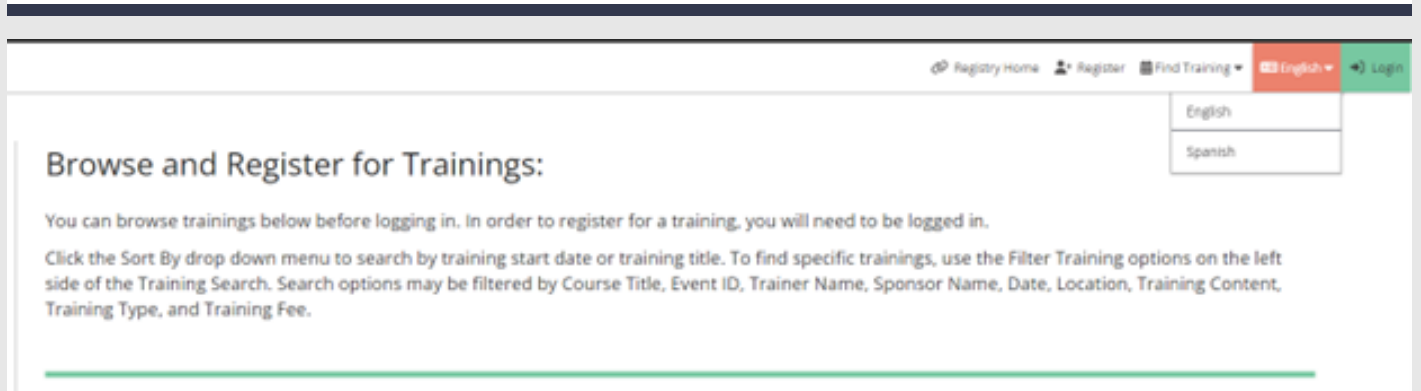


# Access to the Wisconsin Registry Now Available in Spanish!

Users are now able to access the Wisconsin Registry Insight Application in Spanish!

This new, easy-to-use feature is available by clicking "English" in the upper right-hand corner and then selecting the desired language.

This new feature also works for the Statewide Training Calendar, as can be seen in the image below. The process for changing from English to Spanish is the same in the Insight Application.



If you are visiting a page that has not yet been accessed in your chosen language, there may be a slight delay in the page loading.

Also new is the ability to change your language for your communication preferences! When in your Personal Profile, click the Personal Tab, then click Edit Personal. Scroll down to communication preferences and click Spanish if you wish to make that change!

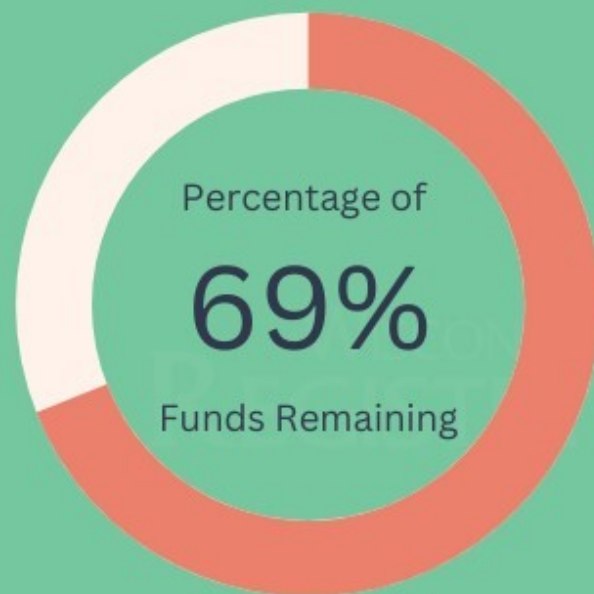
## Foreign Transcript Evaluation Grant

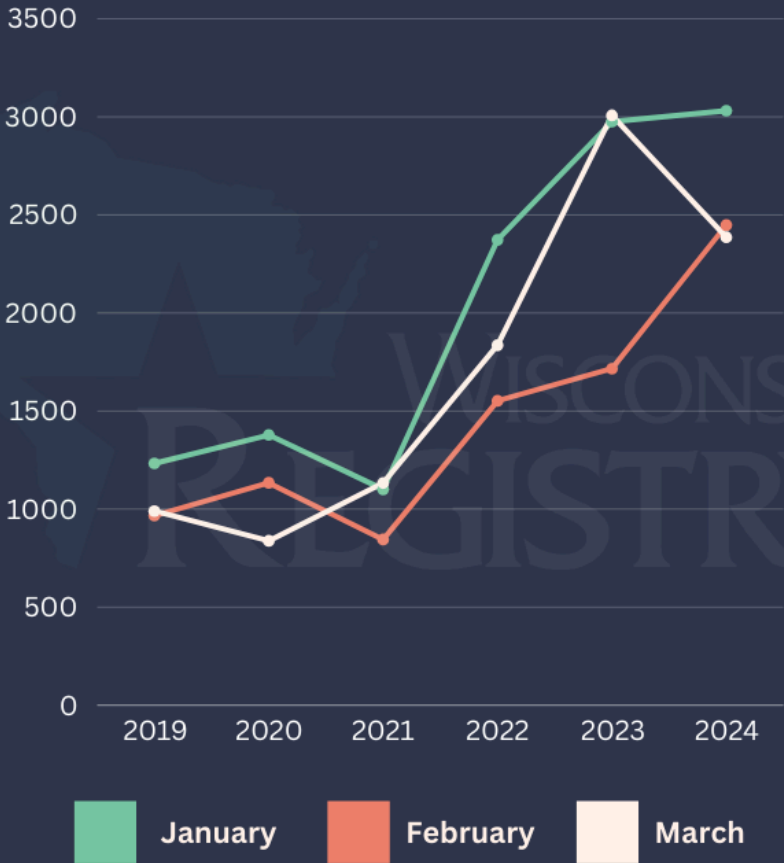
## By the Numbers

The Wisconsin Registry continues to experience a record number of applications in 2024. Through March, the Wisconsin Registry has received 7,865 submitted membership applications.

Compare that to 2019, and the Wisconsin Registry received 3,190 applications from January through March. In just January of this year, we received 3,031 applications. That number is the fourth-highest number of applications submitted for any month dating back to 2009.

Our team continues to work hard to process your applications. See the chart below for a comparison of applications submitted over the first three months over the past six years.
