Beginning September 1, 2024, the Abusive Head Trauma (AHT) Prevention Training for Child Care Providers will be available as an E-Learning training in the Wisconsin Registry Insight Learning Management System (LMS)!



BY THE NUMBERS

15,619

Through July of 2024, 15,619 Wisconsin Registry membership applications have been submitted in the year 2024! In 2023, when the Wisconsin Registry saw a record 23,316 membership applications for the entire year, there were 15,020 applications submitted through July. This means we continue to see applications come in at a record pace and our staff works hard to process those applications!

3,089

Speaking of working hard to process applications, our team processed 3,089 membership applications in July of 2024! The year-to-date total for applications processed through July was 15,356 applications!
