Policy Update: Attendance Roster Finalized After 45 Days

The current 60-day window for the roster to be submitted after the last date of an event delays timely data reporting with community partners. To address this, the window allowed to enter an attendance roster will be reduced to 45 days.

Beginning January 1, 2022, the attendance rosters for all training events will be finalized after **45 days**.

If any revisions are necessary after the 45 days, the Trainer or Training Sponsor Organization can contact the Professional Development Department by emailing support@wiregistry.org or call 608-222-1123 ext 5.

Training on Adult Social Emotional and Health

All courses approved by the Wisconsin Registry fulfill the requirements for continuing education based on the guidelines established by the Wisconsin Department of Children and Families (DCF). The topics approved for continuing education in the DCF Licensing Rules are:

- Prevention and control of infectious diseases
- Medication administration
- Identification of and prevention from hazards
- Emergency preparedness and response planning
- Handling and storage of hazardous materials
- Handling and disposal of bio contaminants
- Child growth and development
- Prevention of and response to emergencies due to food and allergic reactions

- Caring for children with disabilities
- Guiding children's behavior
- Nutrition
- Building and physical premises safety
- Physical activity
- Transportation safety
- Identification and reporting of suspected child abuse or neglect
- Cardiopulmonary resuscitation
- First aid
- Business operations
- Any other topic that promotes child development or protects children's health or safety

Some of the same social and emotional knowledge and skill adults gain from a training can be taught to children or used in the participant's work with children. For Trainers or Training Sponsor Organizations offering training in topics such as self-care, personal health, or social and emotional skills, describe in the course description how the course content relates to an individual's work with children and families and the training will meet the continuing education requirements outlined by DCF.

PDAS Summit

With the use of technology, the Wisconsin Registry held it's first virtual PDAS Summit in September 2021. This year's PDAS Summit focused on the theme Bridging the Gaps: Adapting to Be Inclusive. This 2-day virtual event featured a panelist discussion on barriers and potential solutions to access professional development learning opportunities and build trainer capacity. Multiple robust and in-depth discussions using World Cafe and Carousel Share protocols occurred. Attendees had opportunities to make new connections and build a collaborative network as Trainers and TA Professionals.

These discussions were just the tip of the iceberg. The 2022 PDAS Summit will dig deeper into the potential solutions for some of the identified barriers to accessing professional development opportunities and building trainer capacity. Trainer - Technical Assistance Professional (T-TAP) Instructor Approval

To build trainer capacity, the Wisconsin Registry is looking for new instructors for the T-TAP Courses. Thelf y WI Early Childhood Collaborating Partners (WECCP) and the WI Early Childhood Cross-Sector Professional Development Initiative (WI PDI) developed 3 T-TAP courses to support the knowledge, skills, and

dispositions of T-TAP Professionals. The 3 T-TAP Courses are: *Foundations, Training Professional,* and *Technical Assistance Professional.*

Requirements to be an Approved Instructor of the 3 T-TAP Courses

- Wisconsin Registry Level 13 or Higher
- Tier 3 Trainer Endorsement
- Experience as an adult educator offering Tier Level training
- Completed the T-TAP courses

Wisconsin Registry has 30 days to review the Trainer's application to be an approved T-TAP course instructor.
