Call for Trainer - Technical Assistance Professional (T-TAP) Instructors

Having quality professional development opportunities are critical to the early childhood care and after-school education profession. While Wisconsin has more than 600 approved Trainers and 150 TA Professionals, the need to build Trainer capacity is growing.



While there are individuals interested in becoming a Trainer or TA Professional, finding opportunities to meet the adult education requirement (completing T-TAP Courses) can be challenging. To help address this growing challenge, more instructors who offer these courses across the state are needed.

If you are passionate about the early childhood care and after-school education profession and meet the requirements, we strongly encourage you to share your knowledge and consider becoming a T-TAP Course instructor. Guiding tomorrow's Trainers and TA Professionals can be extremely rewarding. Background Check Processing Update

Trainers and TA Professionals are now required to submit a new background check during their renewal process if the background check on file expires before their next renewal. This update will streamline the renewal process and eliminate potential gaps in Trainer and TA Professional approval.

When it is time to submit a new background check to the Wisconsin Registry, Trainers and TA Professionals will be prompted to submit this documentation during the online renewal application.

Trainers and TA Professionals must have a background check on file with the Wisconsin Registry dated within 5 years. This requirement helps maintain the integrity of both the Wisconsin Registry and the community of approved Trainers and TA Professionals providing professional development to Wisconsin's early childhood care and after-school education field.
