Reminder: Upcoming Changes to Training Event Roster Entry Window

The Wisconsin Registry, our partners, and members rely on timely training event roster data entry. This ensures accurate recognition of members' achievements and ensures partners have the data to make decisions that support the field.

Based on our data and in order to better support these efforts, the training roster entry window is being shortened from 45 days to 15 days.

Some Training Event Roster entry strategies that may help you include:

- If your event allows extra time for homework, set the end date of your event to match the homework due date (be sure to put this in the additional info).
- For in-person events, utilize the Registry app to scan an individual's Registry eID to verify attendance.
