

WISCONSIN REGISTRY PRIVACY POLICY Terms and Conditions

OUR COMMITMENT TO YOUR PRIVACY. We believe the responsible use of information is important for meeting your needs and providing consistent service quality. The more we understand about you and your needs, the better service we can provide. This privacy statement explains data collection and use practices of WISCONSIN REGISTRY Online; it does not apply to offline services. WISCONSIN REGISTRY collects and maintains Personal Identifiable Information (PII) for its members, which is reasonably related to servicing member accounts: the PII we collect and maintain includes name, addresses, telephone number, email address, and last 5 digits of your social security number. Our website and email use "cookies" and similar means to collect aggregate statistical information. Aggregate information is demographic information and does not identify any individual member. We may use or disclose aggregate information for any purpose. A cookie is a small text file that is placed on your hard disk by a Web page server. Cookies are uniquely assigned to you, and are designed to be read only by a Web server in the domain that issued the cookie to you. Cookies are also used to recognize members' preferences, temporarily store session information and past activity at our site in order to provide better service and easier access when members return to our site.
